




COCKTAIL EVENT FLOOR PLAN

FAQ

BOOKING PROCEDURE:

Completion of booking form and 10% payment to reserve the date.

PAYMENT METHODS:

Payments can be made via e-transfer, credit card or cash.

CANCELLATION POLICY:

We have a variable cancellation policy depending on how far in advance you need to cancel your event. The specific terms will be outlined on the booking form, which is considered your contract.

TASTING:

Due to our busy 7 day week trade we cannot provide a tasting service.









TERMS&CONDITIONS

VOWS OF A DIFFERENT KIND

FUNCTION BOOKING \rightarrow A non-refundable deposit of 10% of the minimum spend is required to secure the date of the booking. A further non-refundable \$1500 is required six (6) months prior to the event date to confirm your booking.

PAYMENT OF ACCOUNTS→ Payment of the balance is to be paid at least ten (10) days prior to the event date.

PRICING→ Prices shown in function pack are subject to change without notice. Minimum spend requirement given at time of confirmation of booking will be honoured except where unforeseen circumstances render it unfeasible to do so. The management reserves the right to change or delete menu items based on seasonal availability.

FUNCTION CONFIRMATION → Final guest numbers, and all menu items and dietary requirements are to be finalized fourteen (14) days prior to the event date.

FUNCTION DURATION→ Evening events - Fridays to Sundays - come with exclusive access and are five (5) hours duration between 5:00pm and 11:30pm. Evening events - Mondays to Thursdays - come with exclusive access and are four (4) hours duration between 5:00pm and 10:30pm. A further half hour is given either side for bump in / bump out. Any extra times incur additional costs. Afternoon events are possible on all days except Saturday - further terms and conditions apply. Separate brochure available upon request.

MINIMUM SPEND→ For evening events: **\$4,000** (Monday to Thursday), **\$5,000** (Fridays), and **\$6,000** (Saturdays & Sundays). For afternoon events minimum spend requirements please see separate brochure. Minimum spend must still be paid irrespective of final number of guests confirmed.

18th & 21st BIRTHDAYS→ Guests must include at least 25% adults above 25 years of age. Proof of guest list may be required to be submitted prior to the event. **SECURITY**→ Should it be deemed necessary by managment to ensure safety of staff and guests, the hiring of security staff is \$65 per hour per each staff member. This cost will be added to the final account. Clients will be notified in advance if any security staff will be required.

LIQUOR LICENSING REQUIREMENTS → Management reserves the right to exclude or remove any person from a function or any other areas of the venue in accordance with the Liquor Control Act of Victoria. Under no circumstances are underage guests permitted to consume alcohol. Last drinks will be 10 minutes prior to end of event to ensure no drinking occurs past the end of event time.

ENTERTAINMENT→ Management must be advised of the planned entertainment at the time of the booking. All entertainments and props are subject to management's approval. Smoke machines are not permitted inside the venue.

DECORATIONS→ The venue may be decorated provided no damage is caused to walls, ceilings, furnishings etc. <u>CONFETTI OR PETALS OR SIMILAR ITEMS ARE STRICTLY PROHIBITED</u>. Access to the venue for decorations and setups is available only within bump in time or as approved by management.

EXTERNAL FOOD & BEVERAGE→ No food or beverage is permitted to be brought into the premises for consumption at any time, except for celebration cakes and/or specialty items as approved by management.

PROPERTY DAMAGE OR THEFT→ The client is financially responsible for any damage that is sustained to the venue or any other property owned by or in the care and custody of Little Henri, which is caused by the client or any other person attending and/or affiliated with the function.

CLIENT PROPERTY/VALUABLES→ We do not accept responsibility for the damage or loss of goods left on the premises prior to, during or after a function private or otherwise.

UNFORESEEN CIRCUMSTANCES→ In the event of inability to comply with any of the provision of this contract by virtue of any cessation or interruptions of gas, electricity, industrial dispute, plant or equipment failure, extremes in weather conditions, unavailability of food, other unforeseen contingency or accident, the venue reserves the right to cancel affected bookings and refund any payable deposits without any penalty to the venue.

GENERAL → Management reserves the right at any time to close the bar or terminate a function if any of the above policies are not adhered to.
